



## Breeding Agreement 2012

### 1. CHARGES

Southwind Farms will charge for insemination or packaging of semen as follows:

<b>INSEMINATION FEE/TRAILOR BREED with ultrasound</b>	<b>\$82.00</b>
<b>COLLECTION FEE</b>	<b>\$40.00</b>
<b>COLLECTION AND PROCESSING FEE OF TRANSPORTED SEMEN</b>	<b>\$110.00</b>
<b>DISPOSABLE EQUITAINER FEE</b>	<b>\$40.00</b>
<b>*CANADIAN SEMEN SHIPMENTS (DOES NOT INCLUDE ABOVE FEES)</b>	<b>\$500.00</b>
<b>*Same Day breeding: Contract/paper work processing for unsigned contracts/unbooked mares:</b>	<b>\$200.00 see below #7</b>

\*NOTE: 1) None of these charges include shipping costs of the semen.

2) If the semen does not reach its destination after leaving Southwind Farms custody, the charges above still apply and will be charged. We are not reliable for any shipping issues, flight delays, etc.

3) If you do not have an Equine Express II shipping container to trade with Southwind Farms on the day of breeding, one will be supplied at owner(s) expense.

4) We are only able to bill **ONE** party for any mare that is owned by multiple parties.

5) All trailer breeds will be ultrasounded upon arrival. If the mare is not ready to breed, you will have the option of leaving the mare at Southwind Farm (\$25/per day) or returning with the mare to trailer breed at a later date.

\*NEW\* 6) Due to extensive paper work, currier fees, transport time to and from the USDA for Permits to ship semen to Canada. There will be a \$500 processing fee added to any Canadian shipments. This **DOES NOT** include, shipping fees or regular Semen processing fees you see above.

\*NEW\* 7) If you require semen and you do not have all the required documents signed and on file with Southwind Farm there will be a same day processing fee added to your mares invoice, when the mare is bred and signed documents are received on the same day. Please insure ALL documents are signed and on file with Southwind Farm prior to ordering semen. It is very time consuming for us to process paper work on the same day that semen is requested.

### 2. SOUTHWIND FARMS LIABILITY

Owner shall cause the insemination to be conducted by a qualified person. Southwind Farms shall **not** be liable for and is released from claims arising by reason of the mare not having a live foal or becoming infected, diseased or injured as a result of such breeding.

### 3. SERVICE CHARGES

Southwind Farms will not breed any mare(s) for patrons with overdue accounts. All accounts will be settled upon receipt of duly rendered statements. A service charge of 1.5% per month will be charged on all accounts unpaid after 30 days.

**Regarding accounts unpaid: no mating certificate for the foal will be released until the account is paid in full.**

Failure to timely pay on any amounts due to Southwind Farms pursuant to the agreement, the undersigned shall in addition thereto pay all attorney and/or collection fees incurred by Southwind Farm in connection with the collection thereof to the fullest extent permitted by applicable law.

### 4. OWNER/AGENT LIABILITY

If one owner signs this agreement, when there are multiple owners, the terms and conditions of this agreement will bind all owners. If this agreement is signed by an agent for the owner(s), then the agent and all owners will be bound by the terms and conditions of this agreement.

If any horse is sold or transferred between owners while being bred to any stallions at Southwind Farms, the original owner(s) must notify Southwind Farms of the change in writing, within 10 days of the date of change of ownership. If there is any change in ownership or lease, and Southwind Farms is not notified of the change of ownership or lease the original owner(s) will be held for all the charges of the mare(s) while they are being bred to any stallions at Southwind Farms.
